THE INSOLVENCY AND BANKRUPTCY BOARD OF INDIA (INSOLVENCY
RESOLUTION PROCESS FOR CORPORATE PERSONS) REGULATIONS, 2016

1. That the application was filed by Mr. VedkumarAnand, Prop. Of Anand Enterprises an Operational Creditor of RadhaMadhav Corporation Limited (“Corporate Debtor”), for initiating Corporate Insolvency Resolution Process (“CIRP”) of the Corporate Debtor, under Section 9 of the Insolvency and Bankruptcy Code, 2016 (“IBC”) read with Rule 6 of the Insolvency & Bankruptcy (Application to Adjudicating Authority) Rules, 2016 before the Hon’ble National Company Law Tribunal (“NCLT”), Court No. 1, Ahmedabad CP (IB) No. 669 / 9 / NCLT / AHM / 2019.
2. The matter was admitted by the Hon’ble NCLT vide its order dated 22.10.2020. and Mr. KedarRamratanLadha was appointed as Interim Resolution Professional (“IRP”) with directions to take all such steps as are required under the statute, more specifically in terms of Section 15, 17, 18, 20 & 21 of the Code and to file his report within the statutory period as required under the Insolvency and Bankruptcy Code, 2016.



3. However, an application IA 756 of 2020 was filed for replacement of Mr. Kedar Ramratan Latha, the initially appointed IRP, as he was unable to carry out the duty on account of personal difficulties, pursuant to which Hon'ble NCLT vide order dated 09.11.2020 appointed Mr. Sanjay Badrilal Punglia as IRP.
4. Copy of the order is purported to have been downloaded by the IRP on 11.11.2020. That Mr. Sanjay Badrilal Punglia, the erstwhile IRP had presumed date of appointment as 11.11.2020 on which the copy of order in IA 756 of 2020 in C.P. (IB) 669 of 2019 of Hon'ble NCLT, Ahmedabad Bench (Court No. 1) was downloaded by the IRP, deduced from his declaration in Form A published on 12.11.2020.
5. That thereafter, the Committee of Creditors in its first CoC meeting held on 10.12.2020 approved the resolution for appointment of Rajeev Dhingra, the undersigned Insolvency Professional, having Registration number IBBI/IPA-001/IP-P-01946/2019-2020/12970 to act as Resolution Professional in the matter.
6. In compliance with the provisions of the Insolvency and Bankruptcy Code, 2016 read with Regulation 13(1) and 13 (2) (d) of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016, the undersigned is required to maintain a list of creditors containing their names along with the amount claimed by them, the amount of their claims admitted and the security interest, if any, in respect of such claims and file the said list before the Hon'ble NCLT, Ahmedabad Bench (Court No. 1).
7. The Regulation 14(2) of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016, states that the IRP / RP shall revise the amounts of claims admitted when he comes across additional information warranting such revision. Regulation 13 (2)(d) of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016, states that the said list of creditors maintained by the IRP/RP shall be filed with the Hon'ble Adjudicating Authority.
8. Pursuant to the above Regulations, the undersigned revised and filed the list of 'Creditors last updated as on 05.03.2021' with the Hon'ble Tribunal on 08.03.2021.

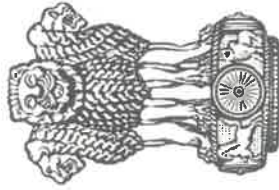

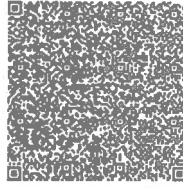

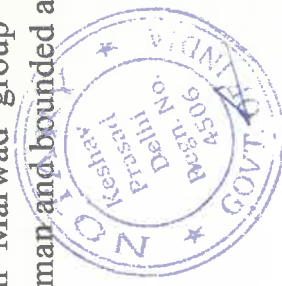
